or Federal and State laws and regulations. To address this responsibility, OLLHCS, Inc. uses a compliance telephone hotline to report suspected violations or questionable conduct.

- a) The hotline telephone number is 877-215-5697 and is available twenty-four Hours a Day seven days a week.
 - b) The telephone number is included in physician agreements, the employee handbook and displays on bulletin boards.
 - c) The Director of Compliance & Privacy Officer responds to hotline calls. When the Director of Compliance & Privacy Officer is not available, an individual is designated by the Director and approved by the Compliance Committee to handle hotline calls.
 - d) Calls may be placed anonymously.
 - e) Callers are not subject to disciplinary action for factual statements regarding instances on non-compliance with federal, state and local laws including fraud, waste and abuse.
 - f) Information provided to the hotline is treated confidentially and as privileged to the extent permitted by applicable law.
 - g) Callers are informed that if the incident requires government authority involvement, the caller may have to reveal his/her identity.
 - h) Intentional false accusations are prohibited. Offenders may be subject to termination.
- 2) Associate calls leading to the discovery of non-compliant activities do not protect the associate against any wrongdoing committed by the associate. However, the disciplinary action taken is not increased against the associate.
- 3) The Department of Health & Human Services – Office of Inspector General Hotline telephone number, 1-800-HHS-TIPS (447-8477) is also posted in prominent areas.
